मुंबई मेट्रो लाईन ३ या भूमिगत मेट्रोची २२ किमीची लाईन सुरू केली आहे. त्यामध्ये १६ स्थानके आहे. या मार्गिकवरून दररोज ४५ ते ५० हजार स्थानांकरिता प्रवास करतात. त्यापैकी सर्वात शेवटचे दिक्षेणकडील आचार्य अत्रे चौक स्थानक आहे, ते सुरू करत असताना त्याच्या एकूण ६ मेट्रो एक्झिटपैकी आपण २ मेट्रो एक्झिट सुरू केलेले आहे. उरलेल्या २ मेट्रो एक्झिट सुरू होण्यासाठी २ ते ३ महिन्यांचा कालावधी लागणार आहे. त्यापैकी एका मेट्रो एक्झिटसाठीचे प्रकल्प जे पीट होते, त्याच्याभोवती असलेली स्ट्रॉम वॉटर ड्रेन यंत्रणा ही अतिवृष्टीमुळे आणि त्यामागेमागे झालेल्या हायटाइडमुळे प्रभावित झाली. ही यंत्रणा पूर्णपणे प्रकल्प गेल्यामुळे त्यातून समुद्रात जाणे पाण्याचा विसर्ग होणार होता, तो झाला नाही. पण हे पाणी भुयारी मार्गाच्या आत जे काम सुरू होते, त्याच्या पीटमध्ये आले आणि जवळभर एका तासाभरात ११ लाख लीटर पाणी त्या लहानशा

पीटमध्ये जमा झाले, अशी माहिती भिडे यांनी दिली.

हे पाणी जमा झाल्यानंतर ते जाण्यासाठी जागा नसल्याने हे सर्व पाणी स्थानकात शिरले. या स्थानकाच्या एन्ट्रीचे काम सुरू असल्याने त्याच्या बाहेर बंदर्वाळ तयार करून एक पूर्वनियंत्रण योजना ठेवलेली होती. परंतु, त्यामध्ये इतके पाणी धरून ठेवण्याची क्षमता नव्हती, ज्यामुळे हे पाणी बंदर्वाळवरून स्थानकामध्ये गेले. हे झाल्याबरोबर स्थानकामधील यंत्रणा तात्काळ कामाला लागली. स्थानकामध्ये असलेल्या काही लोकांना बाहेर काढण्यात आले. इतर ज्या काही गोष्टी काटकोरपणे पाठ्यायच्या होत्या, त्या सुद्धा पाठवण्यात आल्या. स्थानकातील इतर काम थांबवण्यात आले आणि मेट्रो मार्ग हा त्याच्या आधीच्या स्थानकापर्यंत म्हणजे आरे-जेव्हीएलआर ते वरळीपर्यंत चालू ठेवण्यात आला, असे स्पष्टीकरण भिडे यांनी दिले.
